  - And then "Validate"
- You can now view a full summary of the votes you cast
  - You will receive your vote confirmation by e-mail

## GIVE PROXY TO THE CHAIRMAN

- Click on the button "Vote at the AGM"
  - And then on "Give proxy to the Chairman"
- Click on "Continue"
  - And then "Validate"
- You can now view a full summary of the votes you cast
  - You will receive your vote confirmation by e-mail

## GIVE PROXY TO A MENTIONED PERSON

- Go to the Shareholders' Website <http://www.cmcics-nominatif.com/en>
- Click on the button "Vote at the AGM"
  - And then on "Give proxy to a mentioned person"
- Complete the details of the third party who will vote for you
  - And then click on "Continue"
- You can now validate your proxy appointment
  - You will receive your confirmation by e-mail

## REQUEST AN ATTENDANCE CARD

- Click on the button "Vote at the AGM"
  - And then on "Request an attendance card"
- To download your admission card in digital format:
  - Check the box you wish to download and print the attendance card
  - Then click on "Validate"
- To receive your attendance card by ordinary mail:
  - Check the box Please send my attendance card to my postal address
  - Complete your contact details and then click on "Validate"
- You can now view your confirmation
  - You will receive your confirmation by e-mail
